## Cyber Privacy and Human Rights. Study Case: Mexican Olimpia Law

#### Resumen

En el contexto de la globalización, la privacidad informática y los derechos humanos adquieren una complejidad significativa. Este fenómeno plantea desafíos para preservar los derechos humanos de cuarta generación debido al incremento de casos de violencia digital. En este contexto, los derechos de las mujeres se ven vulnerados ya que representan la mayor parte de víctimas de este tipo de violencia. En este escenario, un marco legal y ético sólido se vuelve esencial para tratar los conflictos entre la necesidad de seguridad y la preservación de los derechos humanos. En este trabajo se aborda la normativa de la Ley Olimpia de México y sus implicaciones en cuanto a los derechos de las mujeres en privacidad informática a través de una metodología cualitativa de revisión tradicional de la literatura.

### **Abstract**

In the context of globalization, computer privacy and human rights take on significant complexity. As information and communication technologies advance, global interconnection intensifies the cross-border transfer of data. This phenomenon poses challenges-preserving fourth-generation human rights due to the increase in cases of digital violence. In this context, women's rights are violated as they represent the majority of victims of this type of violence. In this scenario, a solid legal and ethical framework becomes essential to address the conflicts between the need for security and the preservation of human rights. This paper refers to the regulations of the Olimpia Law of Mexico and its implications in terms of women's rights in computer privacy through a qualitative methodology of traditional literature review.
