# **INTEGRATION BLOCS: ADVANTAGES AND DISADVANTAGES IN DEVELOPING ECONOMIES IN LATIN AMERICA. LITERATURE REVIEW**

## **ABSTRACT**

This research critically analyzes the effects of regional economic integration on the developing economies of Latin America, considering both its benefits and limitations. Through a systematic literature review using the PRISMA approach, over one hundred peer-reviewed sources were collected from databases such as Scopus and Web of Science, covering studies from the last ten years. The findings show that, while regional integration has contributed to increased intra-regional trade, foreign investment attraction, and technical cooperation, these benefits have not been homogeneous or sustained. Significant structural challenges remain, such as institutional weakness, normative fragmentation, and the lack of a shared strategic vision among member countries. The study concludes that integration can be a powerful tool for regional development, provided it is accompanied by deep institutional reforms, redistributive policies, and cooperative governance that transcends political cycles. Recommendations are made to strengthen the institutional framework of regional blocs, harmonize regulations, and consolidate productive chains with higher value-added, aiming for a more inclusive, resilient, and sustainable integration.

# **BLOQUES DE INTEGRACIÓN: VENTAJAS Y DEVENTAJAS EN LAS ECONOMÍAS EN DESARROLLO DE LATINOAMÉRICA. REVISIÓN DE LITERATURA**

## **RESUMEN**

Esta investigación analiza de manera crítica los efectos de la integración económica regional en las economías en desarrollo de América Latina, y considera tanto sus ventajas como sus desventajas. Por medio de una revisión sistemática de la literatura utilizando la metodología PRISMA, se recopilaron 50 fuentes revisadas por pares, las cuales fueron extraídas de bases de datos como Scopus y Web of Science, y abarcan estudios de los últimos diez años. Los resultados evidencian que, aunque la integración regional ha favorecido el incremento del comercio intrarregional, la atracción de inversión extranjera y la cooperación técnica, estos beneficios no han sido homogéneos ni perdurables. Es por ello que, persisten retos estructurales significativos, como la fragilidad institucional, la fragmentación normativa y la carencia de una visión estratégica común entre los países miembros. La investigación concluye que la integración puede constituir una herramienta muy útil para el desarrollo regional, siempre que se acompañe de reformas institucionales profundas, políticas redistributivas y una gobernanza cooperativa que supere las coyunturas políticas. El estudio ofrece recomendaciones para fortalecer la institucionalidad de los bloques regionales, armonizar las normativas y consolidar cadenas productivas con mayor valor agregado, buscando una integración más inclusiva, resiliente y sostenible.
