# The Role of the World Trade Organization in the Face of the Challenges of Regional Trade Agreements. Literature Review

### **ABSTRACT**

This research aimed to analyze how the World Trade Organization (WTO) addresses the challenges arising from the proliferation of Regional Trade Agreements (RTAs), through a systematic literature review based on the PRISMA methodology. The study explored the main tensions between the multilateral trading system and the regulatory autonomy promoted by regional agreements. As a result, seven critical challenges were identified, including regulatory fragmentation, the crisis of the WTO dispute settlement mechanism, the exclusion of developing countries, the lag in addressing emerging issues such as digital and environmental trade, and the consolidation of exclusive trade blocs that marginalize developing economies. It can be concluded that the WTO must evolve into a more inclusive, flexible, and proactive institution in order to remain a relevant regulatory body for global trade. Although several solutions have been proposed by the WTO to address these challenges, they have largely remained at an informational level without being effectively implemented through binding regulation.

### El Rol de la Organización Mundial de Comercio Frente a los Desafíos de los Acuerdos Comerciales Regionales. Revisión de Literatura

### **RESUMEN**

La siguiente investigación tuvo como objetivo analizar cómo la Organización Mundial del Comercio se enfrenta a los desafíos que han sido resultado de la creación de Acuerdos Comerciales Regionales (ACR). Bajo una revisión sistemática de literatura, basándose en la metodología PRISMA, se analizaron las principales tensiones entre el sistema multilateral y la autonomía normativa que impulsan los acuerdos regionales. Como resultado, se evidenció siete desafíos críticos, entre ellos la fragmentación normativa, la crisis del mecanismo de solución de diferencias de la OMC, la exclusión de países en desarrollo, el rezago frente a temas emergentes como el comercio digital y ambiental, y la consolidación de bloques comerciales exclusivos que dejan de lado a países en vías de desarrollo. Se puede concluir que la OMC deberá transformarse en una organización más inclusiva, flexible y proactiva para seguir siendo un ente regulador relevante para el comercio mundial. Para ello, se ha mostrado varias de las soluciones que la OMC ha propuesto para enfrentar estos desafíos, pero que únicamente han quedado con un papel informativo sin llegar a regularlos.
